3 说明

TCAN1046V-Q1 和 TCAN1048V-Q1 (TCAN104xAV-Q1) 是双路高速控制器局域网 (CAN) 收发器, 符合 ISO 11898-2:2016 高速 CAN 规范的物理层要求。

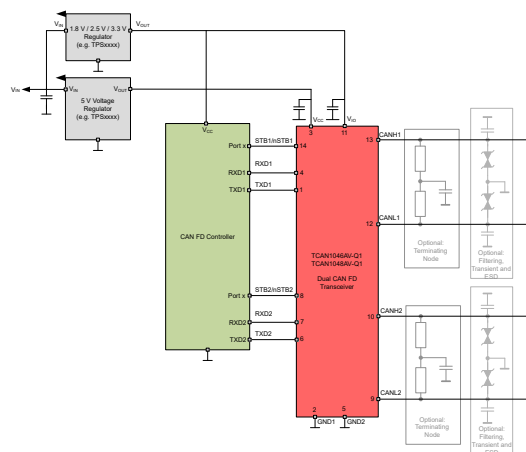
TCAN104xAV-Q1 收发器支持传统 CAN 和 CAN FD 网络 (数据速率高达 8 兆位/秒 (Mbps))。该器件包含通过 V_{IO} 端子实现的内部逻辑电平转换功能, 允许将收发器 IO 直接连接到 1.8V、2.5V、3.3V 或 5V 逻辑 IO。

两个 CAN 通道通过待机引脚支持独立的模式控制。因此, 可以在不影响其他 CAN 通道状态的情况下将每个收发器置于低功耗状态待机模式。在待机模式下, 该器件可通过 ISO 11898-2:2016 定义的唤醒模式 (WUP) 实现远程唤醒。

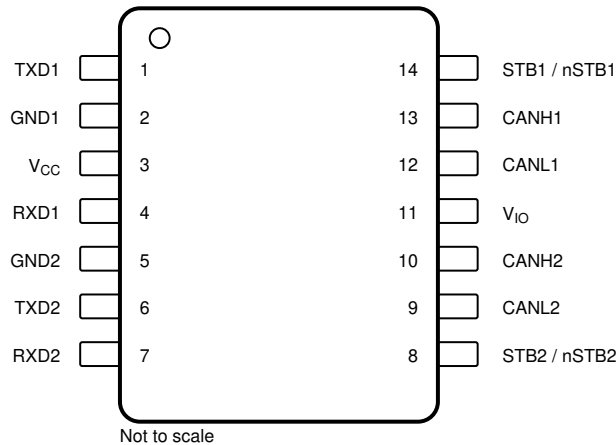


图 6-1. D Package , 14 Pin SOIC, Top View

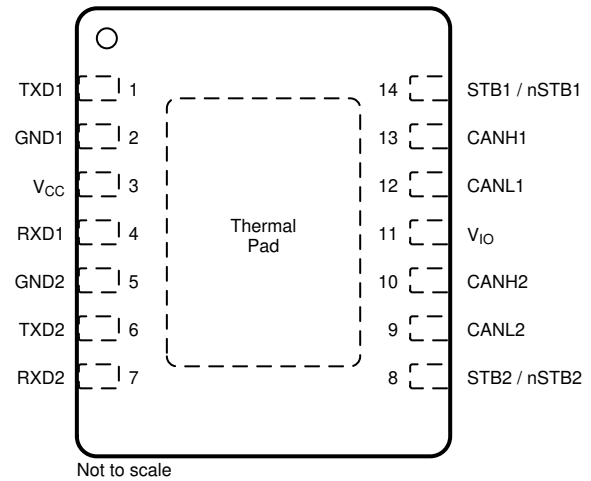


图 6-2. DMT Package, 14 Pin VSON, Top View

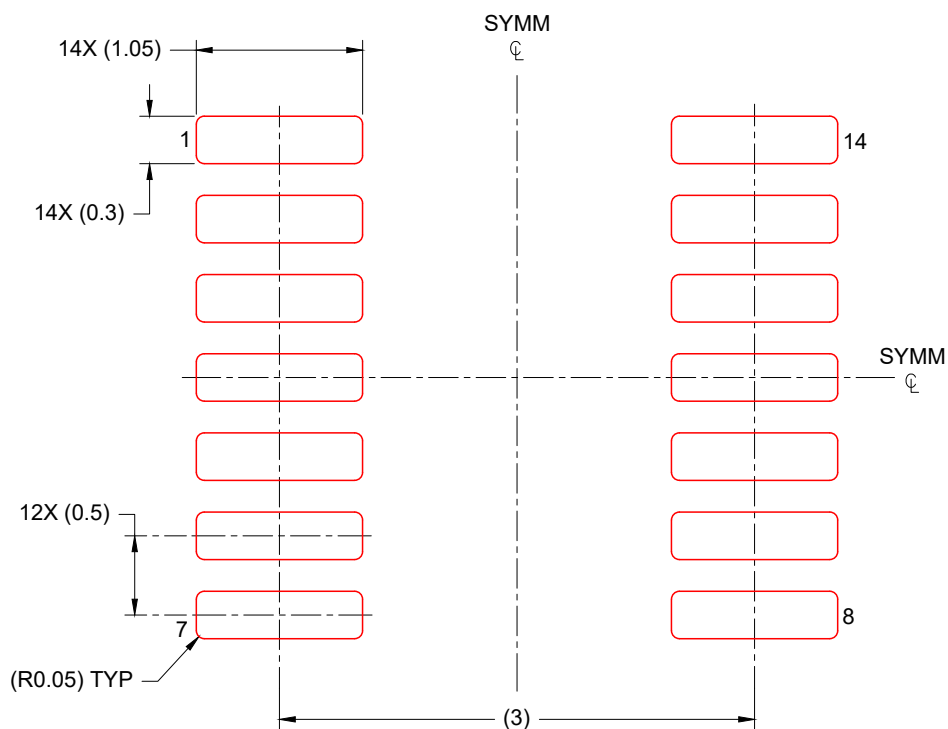
LAND PATTERN EXAMPLE

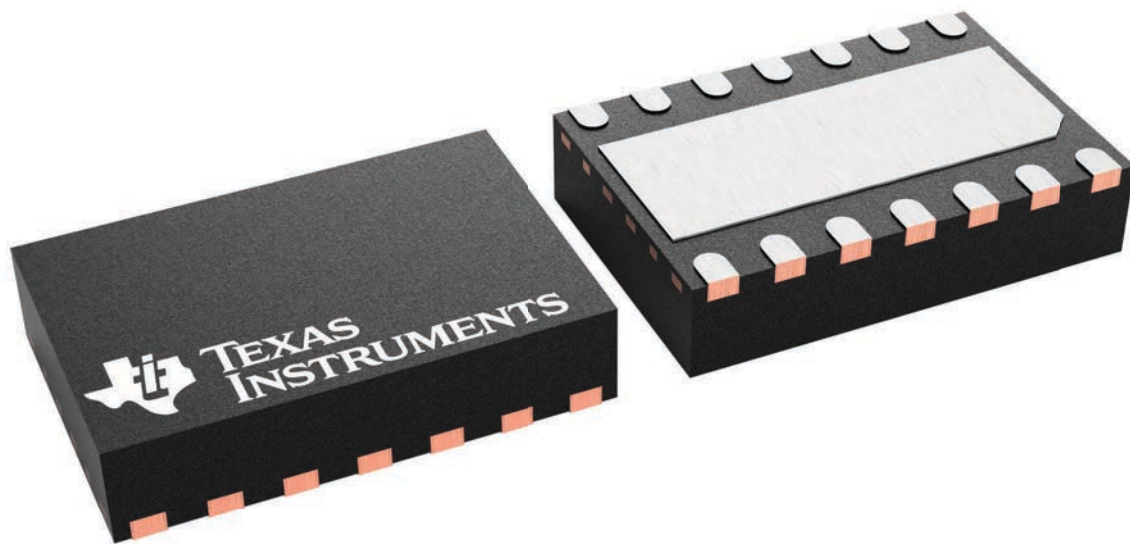

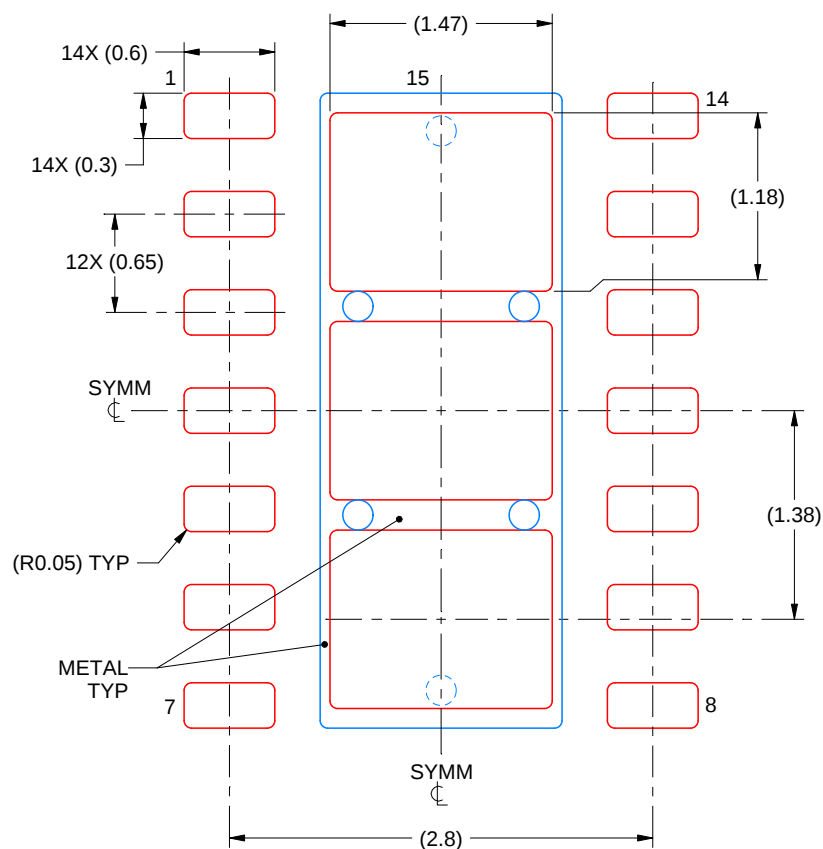
